The World Urban Forum is a non-legislative technical forum convened by the United Nations Human Settlements Programme (UN-Habitat) on a biennial basis beginning in 2002. It is recognized as the foremost global arena for discussions in the field of sustainable urban development and human settlements. WUF11 will be organized jointly with Poland's Ministry of Development Funds and Regional Policy and the Municipal Office of Katowice. The theme of WUF11, Transforming Our Cities for a Better Urban Future, cuts across various national and local government portfolios. WUF11 presents a strategic opportunity for multi-stakeholder cooperation in the implementation of the New Urban Agenda and the Sustainable Development Goals, in particular Goal 11 (Make cities and human settlements inclusive, safe, resilient and sustainable). Participants in WUF11 will include local and national leaders; government officials; representatives of civil society, academia, the private sector and grassroots organizations, as well as other policymakers and decision makers from around the world

I am confident that WUF11 in Katowice will allow all of us to exchange good practices and lessons learned in order to advance sustainable development and urban transformation. The WUF11 exhibition will also offer a unique opportunity for showcasing urban solutions and networking with practitioners and policymakers facing similar development opportunities and challenges. I would like to encourage your delegation to participate actively in all the WUF11 events in order to enrich the experiences at and the success of the Forum session. I hope that your country's participation will enable you to engage with us and other participants in discussions on the theme of WUF11, including the need to accelerate the implementation of the Sustainable Development Goals and the New Urban Agenda.

I am pleased to inform you that UN-Habitat will support the participation of least developed countries by providing a return economy-class air ticket using the most direct and economical route and the daily subsistence allowance for one representative per country for the duration of the eleventh session of the Forum. In that regard, I would be grateful if your ministry would submit the details of the individual nominated for such support by 29 April 2022, together with the completed form that is attached to this letter and a copy of the bio-data page of the nominee's passport.
